The Paracelsus Clinic in Switzerland is Europe's biggest center of bio-integrative medicine. The holistic therapy concept practiced at Paracelsus harmoniously combines orthodox and complementary medical knowledge allowing a wide range of treatments.

1. Biological medicine

Biological medicine, also known as complementary medicine or integrative medicine treats the whole organism as a functional unity (body-mind-soul). Symptoms are always an outward expression of an underlying dysfunction that can be remedied by stimulating the body's own regulatory forces. We try to find and treat the root causes of the disease/ailment and thus give the body a chance to heal itself. Optimizing the general metabolism and milieu of the body is thus the top priority. This involves detoxification and intestinal cleansing protocols, the latest methods of immune stimulation, as well as a wide spectrum of revitalizing therapies.

2. Biological dentistry

The roots of our teeth are linked to specific meridians (body energy pathways) and by way of this energy system, dental foci may profoundly affect the whole organism. In addition, old or new materials used in dental fillings can be toxic and cause a number of physiological problems.

Optimal oral health is also part of a holistic treatment. Inflammation of the gums, dental foci or periodontitis weaken our immune system. Various diseases affecting organs and joints, as well as spinal ailments are often associated with dental issues.

Our goal is to provide dental restorations that are biologically compatible with your body. Dentists at Paracelsus generally do not use chemically based medications such as antibiotics or cortisone. Simple swelling and pain can be successfully treated with homeopathic remedies.

We completely abstain from toxic materials, especially amalgam and dental materials like ceramics are free of Xenohormones etc. It is important to have a proper and safe removal procedure of harmful materials. Otherwise, toxic gases can be inhaled and/or toxic particles can be swallowed. The Paracelsus clinic is the biggest center of competence in Switzerland where amalgam and other toxic dental materials are safely and gently removed using the latest methods, in addition to offering a simultaneous individualized detoxification therapy.

3. Conventional medicine in relation to biological medicine

The effectiveness of complementary medicine and its treatment methods are in part controversial in traditional medical communities. In principle, we do not consider biological medical methods and therapies as an alternative to conventional medical practices, but rather as an addition! We think it as important to integrate your primary care physician in your home country in your Paracelsus treatment plan. Therefore, we encourage you to discuss the proposed treatments at Paracelsus with your conventional medical doctor.

4. Insurance

The services of Paracelsus clinic are not covered by international insurances. However, you may want to get in contact with your medical aid and ask for possible reimbursements. Concerning questions about costs and payment please contact us.

5. Excerpt from Paracelsus terms and conditions regarding "costs for late payment"

The Paracelsus Klinik Lustmühle AG works together with a collection service provider and we have contractually agreed to explain these conditions to our patients at the time of registration confirmation: Invoices not paid we send after the first or possibly 2nd reminder for payment to this independent collection service, which then issue the following service fees (80 days after date of invoice, on day o delivery to the collection service provider) added to the debt amount, depending on the amount of the claim in CHF: 37 (up to 19); 58 (up to 59); 145 (up to 399); 225 (to 999); 285 (to 1'999); 385 (tol 2'999); 575 (to 4'999); 685 (up to 6,999); 825 (up to 9,999); 1,375 (up to 9,999); 2'600 (up to 49'999); 6% of the claim (from 50'000).

For uncomplicated and fast processing of diagnostics, we take the liberty to forward your personal data (name, first name, address, phone number, e-mail, date of birth, prescription) to the above-mentioned organizations we collaborate with on request. If you would like to include your primary care physician in your home country in this data exchange, we will gladly take his/her contact data from the questionnaire.

At your first consultation at Paracelsus you doctor in charge will inform you of your diagnosis from a biological medical point of view, of the proposed therapy and any possible alternatives, as well as of the risks associated with the proposed treatments. 8. Consent form

At the same time, I agree that in specific circumstances, in Switzerland approved remedies, that are individually dosed to my needs, are administered, in dosages which do not relate to the officially approved indications (including injections and infusions). This consent is given on a voluntary basis and I may revoke it at any time with effect for the future. The revocation of my consent does not affect the legality of the processing that has taken place up to that point.
